**PROVINCIAL RESOLUTION NO. 1016-2023**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A RENEWAL OF MEMORANDUM OF AGREEMENT WITH LAND BANK OF THE PHILIPPINES FOR THE PROVISION OF THE FREE SPACE AT THE FAÇADE OF THE FINANCE BUILDING, PROVINCIAL CAPITOL COMPOUND, WHERE THE AUTOMATED TELLER MACHINE (ATM) IS LOCATED**

**WHEREAS**, pursuant to Provincial Resolution No. 246-2012 dated May 28, 2012, the Sangguniang Panlalawigan authorized the Provincial Governor, Amado T. Espino, Jr., to enter into a Memorandum of Agreement (MOA) with the Land Bank of the Philippines for the construction of an offsite Automated Teller Machine (ATM) to be located at the Provincial Capitol Compound;

**WHEREAS**, the Memorandum of Agreement (MOA) on ATM installation at the Finance Building, Provincial Capitol Compound, which was executed on March 13, 2014, has already lapsed;

**WHEREAS**, in order to ensure the continuity and commitment of the services of Landbank to the employees of the Provincial Government and other clienteles, there is a need to renew the subject MOA for the provision of the free space at the façade of Finance Building;

**WHEREAS**, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;



**WHEREFORE**, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


