RESOLUTION NO. 1019-2023

DECLARING ORDINANCE NO. 2023-34 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY OF ALAMINOS, IN THE AMOUNT OF EIGHT HUNDRED MILLION PESOS (P800,000,000.00) WITH THE DEVELOPMENT BANK OF THE PHILIPPINES TO FINANCE THE FOLLOWING PRIORITY DEVELOPMENT PROJECTS: a) LOT ACQUISITION (SITE OF THE CITY HALL BUILDING (ANNEX) AND ALAMINOS CITY PUBLIC MARKET (P300,000,000.00); b) CONSTRUCTION OF CITY HALL BUILDING (ANNEX) (P342,447,761.00); AND c) CONSTRUCTION OF ALAMINOS CITY PUBLIC MARKET (P157,552,239.00) AND FURTHER AUTHORIZING CITY MAYOR ARTH BRYAN C. CELESTE, TO REPRESENT THE CITY AND SIGN ON ITS BEHALF THE LOAN AND/OR ENTER INTO TERM LOAN AGREEMENT AND ASSIGNMENT OF DEPOSIT WITH HOLD-OUT AND CONTROL AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-34 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Coordinator have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 22 (a) (5) (c), 296 (a) & (b), 297 (a), (b) & (c) and 458 (b) (vi) of R.A. 7160;


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2023-34 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled “An Ordinance authorizing the proposed borrowing of the City of Alaminos in the amount of Eight Hundred Million Pesos (P800,000,000.00) with the Development Bank of the Philippines to finance the following priority development projects: A) Lot Acquisition (Site of the City Hall Building (Annex) and Alaminos City Public Market (P300,000,000.00); B) Construction of City Hall Building (Annex) (P342,447,761.00); and C) Construction of Alaminos City Public Market (P157,552,239.00) and further authorizing City Mayor Arth Bryan C. Celeste, to represent the City and sign on its behalf the loan and/or enter into Term Loan Agreement and Assignment of Deposit with Hold-Out and Control Agreement with the Development Bank of the Philippines” as within the conferred powers of the Sangguniang Panlungsod to enact;
