**RESOLUTION NO. 102-2023**

**APPROVING RESOLUTION NO. 163-2022 OF THE SANGGUNANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 163-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Urbiztondo, Pangasinan prepared their Supplemental Investment Program (SIP) No. 4 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 06, S-2022 dated December 28, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱2,170,398.00, covers the augmentation of funds for Personal Services (granting of Service Recognition Incentives to qualified personnel) and Maintenance and Other Operating Expenses (MOOE) of some municipal offices, and implementation of LDRRM projects of the LGU; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 4 for CY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 5-2022 dated December 29, 2022.




