DECLARING MUNICIPAL ORDINANCE NO. 11, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE LOCAL YOUTH DEVELOPMENT OFFICE (LYDO) IN THE MUNICIPALITY OF BANI, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Ordinance No. 11, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Human Resource Management and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (2) (iv), 76, 78, 443 (c) 447 (a) (1) (viii) of R. A. No. 7160; R.A. No. 8044, otherwise known as the "Youth in Nation-Building Act" and Republic Act No. 10742 or the SK Reform Act of 2015;

WHEREAS, however, in the event that the regular plantilla position of the above functions will be created an ordinance enumerating the salary grade allocation, position title and revised qualifications in accordance with the Qualification Standards issued by Civil Service Commission and the Index of Occupational Services, Position Title and Salary Grades for Local Government (IOS-LGU), CY 2021 Edition should be submitted;
