RESOLUTION NO. 1023-2023

DECLARING MUNICIPAL ORDINANCE NO. 12, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE BUSINESS PERMIT AND LICENSING OFFICE (BPLO) AS ONE SECTION UNDER THE OFFICE OF THE MUNICIPAL TREASURER, MUNICIPALITY OF BANI, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Ordinance No. 12, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Human Resource Management and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76, 78, 443 & 447 (a) (1) (viii) of R. A. No. 7160; Republic Act No.11032, entitled "An Act Promoting Ease of Doing Business and Efficient Government Service Delivery Act of 2018", otherwise known as the "Youth in Nation-Building Act" and Republic Act No. 10742 or the SK Reform Act of 2015;

WHEREAS, the Local Government Unit should provide funding for the implementation of the said ordinance so as not affect the appropriations already allocated to specific programs of the LGU;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—
