RESOLUTION NO. 1024-2023

DECLARING MUNICIPAL ORDINANCE NO. 13, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE LOCAL POPULATION OFFICE AS ONE SECTION UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER IN THE MUNICIPALITY OF BANI, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Ordinance No. 13, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Human Resource Management and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17, 76, 78 (b) (2) (iv), 443 (c) & 447 (a) (1) (viii) of R. A. No. 7160 and Department of the Interior and Local Government Memorandum Circular No. 2019-100 dated July 8, 2019 re: Designation of Local Population Officers and Mobilization of Community Officials, Volunteers, and Workers to Intensify the Implementation of the National Program on Population and Family Planning;

WHEREAS, the Local Government Unit should provide funding for the implementation of the said ordinance so as not affect the appropriations already allocated to specific programs of the LGU;
