RESOLUTION NO. 1025-2023

DECLARING MUNICIPAL ORDINANCE NO. 14, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE LOCAL EPIDEMIOLOGY AND SURVEILLANCE UNIT (LESU) UNDER THE MUNICIPAL HEALTH OFFICE, MUNICIPALITY OF BANI, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Ordinance No. 14, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Human Resource Management and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Republic Act No. 11332, or "An Act Providing Policies and Prescribing Procedures on Surveillance and Response to Notifiable Diseases, Epidemics, and Health Events of Public Health Concern, and Appropriating Funds Therefor, Repealing for the Purpose Act No. 3573, otherwise known as "The Law on Reporting of Communicable Diseases"; and the Philippine Integrated Disease Surveillance and Response (PIDSR) System, and Sections 76, 78 & 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, the Local Government Unit should specifically provide the appropriations so as not affect the appropriations already allocated to specific programs of the LGU;
