#### **RESOLUTION NO. 1027-2023**

DECLARING MUNICIPAL ORDINANCE NO. 05, S-2023 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "AN ORDINANCE MANDATING ALL PERSONS ENGAGED OPERATING WITHIN THE TERRITORIAL JURISDICTION OF BURGOS, PANGASINAN ENGAGED IN THE MANUFACTURING, SELLING, OR DISTRIBUTING PNP UNIFORMS, INSIGNIAS AND OTHER ACCOTREMENTS TO SECURE CERTIFICATE OF CONFORMITY AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN ENACT

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 05, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (3) (ii) of R. A. No. 7160 and Executive Order No. 297, Series of 2000;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of posting and publication requirements pursuant to Sections 59 (c) and 511 (a) of R. A. No. 7160;
