**RESOLUTION NO. 1029-2023**

**APPROVING RESOLUTION NO. 2023-239, S-2023 OF THE SANGGUNANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2023-05 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN, FOR CALENDAR YEAR 2023, REQUIRING A TOTAL FUNDING OF TWELVE MILLION SIX HUNDRED NINETY SEVEN THOUSAND SEVEN HUNDRED SEVENTEEN PESOS AND THIRTY FIVE CENTAVOS (P12,697,717.35)”**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2023-239, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 2023-05, CY 2023. This was endorsed by the Council, through MDC Resolution No. 2023-10, Series of 2023, dated September 7, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱12,697,717.35, covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and implementation of development projects and other priority projects of the LGU.

The proposed projects to be funded from the 20% Development Fund, amounting to P4,200,000.00, are based on Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).

Likewise, the proposed project to be funded from the Tobacco Excise Tax, in the amount of P345,577.95, conforms with Local Budget Memorandum No. 83 and 84 of the Department of Budget and Management; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2023-04, FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-028, Series of 2023 dated October 2, 2023.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—


