RESOLUTION NO. 1034-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN INVOLVING TOTAL APPROPRIATIONS OF P103,932,125.35, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2023 involving total appropriations of P103,932,125.35, which was enacted on August 8, 2023 through Appropriation Ordinance No. 2023-02;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A 7160 and Article 414 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
4. That the salary grade of Nurse II should be adjusted from Salary Grade 15 to Salary Grade 16 to conform with Budget Circular No. 2021-2 dated August 25, 2021 issued by Department of Budget and Management; and
5. That the position title of Cashier I should be changed to Administrative Officer I (Cashier I) to conform with the Index of Occupational Services, Position Titles and Salary Grades for Local Government (IOS-LGU), Calendar Year 2021 Edition.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


