**APPROVING RESOLUTION NO. 2022-336 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "RESOLUTION AMENDING SB RESOLUTION NO. 2022-62, "RESOLUTION APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 01, CALENDAR YEAR 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2022-336 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council – Executive Committee of Mangaldan, Pangasinan proposed for the amendment of project location for the construction of Multi-Purpose Drying Pavement from Brgy. Macayug to Brgy. Inlambo under the LGU's Supplemental AIP No. 1, CY 2022. This was endorsed by the Council, through MDC Resolution No. 6-S.2022 dated October 26, 2022, to the Sangguniang Bayan for approval;

2. The project has been included in the LGU's Supplemental AIP No. 1, CY 2022, with a project cost of ₱989,481.50 and proposed for funding from the LGU's share from the 2018 and 2019 Tobacco Excise Tax. The project is based on Local Budget Memorandum No. 84 of the Department of Budget and Management (DBM); and
3. Funding for the project is embodied in the LGU's Amended Supplemental Budget No. 2-A, CY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-07, dated December 5, 2022.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;


