RESOLUTION NO. 1046-2023

DECLARING ORDINANCE NO. 2023-017 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE WATER-BREAK TIME IN THE PRIVATE AND PUBLIC SCHOOLS OFFERING DAY CARE, ELEMENTARY, HIGH SCHOOL CLASSES IN THE MUNICIPALITY OF TAYUG, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2023-017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 17 (b) (2) (iii) and (iv) of R. A. No. 7160 and III (1) of the Department of Education (DepEd) Order No. 10, S-2016; Further, the LGU shall coordinate with the DepEd in the implementation of the subject ordinance pursuant to IV (B) (5) (2) of said DepEd Order No. 10, S-2016;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—


