PROVINCIAL RESOLUTION NO. 1051-2023

AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE AMOUNTING TO P1,000,000.00 TO THE CITY OF GENERAL SANTOS, PROVINCE OF SOUTH COTABATO, DUE TO THE DAMAGES CAUSED BY THE RECENT EARTHQUAKE

WHEREAS, on November 17, 2023, a 6.8 magnitude earthquake struck SOCCSKSARGEN Region, particularly in the City of General Santos, Province of South Cotabato which caused widespread destruction of different public and private infrastructures;

WHEREAS, the Provincial Government of Pangasinan has decided to extend financial assistance in the amount of One Million Pesos (P1,000,000.00) to the beleaguered area;

WHEREAS, the above-significant humanitarian endeavor of the Provincial Government of Pangasinan will greatly benefit thousands of families in the areas that were affected by the earthquake;

WHEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was —

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the grant of financial assistance amounting to P1,000,000.00 to the City of General Santos, Province of South Cotabato, due to the damages caused by the recent earthquake;


