PROVINCIAL RESOLUTION NO. 1052-2023

AMENDING THE COMPOSITION OF THE STANDING COMMITTEES OF THE 11TH SANGGUNIANG PANLALAWIGAN OF PANGASINAN (2022-2025) TO INCLUDE THE NEW SK PROVINCIAL PRESIDENT, SP MEMBER JOYCE D. FERNANDEZ

WHEREAS, DILG Memorandum Circular 2023-168 has set forth the timeline for the conduct of the Panlalawigan Pederasyon ng mga Sangguniang Kabataan Election and the said election for the Province of Pangasinan was conducted last November 28, 2023;

WHEREAS, based on the results of the official copy of the Certificate of Canvass and Proclamation of the 2023 Panlalawigan Pederasyon Election ng mga Sangguniang Kabataan for the Province of Pangasinan transmitted by the DILG to the Sangguniang Panlalawigan, dated November 29, 2023, SP Member Joyce D. Fernandez is now the proclaimed SK Provincial President and therefore, new member of the sanggunian;


