**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM  
NO. 8 OF THE PROVINCE OF PANGASINAN FOR CALENDAR  
YEAR 2023**

**WHEREAS**, presented for consideration is the Supplemental Investment Program No. 8 of the Province of Pangasinan for Calendar Year 2023 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 14-23;

**WHEREAS**, Supplemental Investment Program No. 8 contains other priority programs, projects and activities that are not included in the approved 2023 Annual/Supplemental Investment Programs of the Province of Pangasinan;

**WHEREAS**, programs and projects included in the Supplemental Investment Program with a total investment requirement of P624,785,987.91 covers the provision of farm inputs, repair and rehabilitation of various barangay/farm to market roads and construction of Umingan District Hospital with Site Development to be funded from the share of the Province from tobacco excise tax;

**WHEREAS**, the Supplemental Investment Program contains fund augmentation for the Maintenance and Other Operating Expenses of provincial hospitals and for Personal Services for the granting of Service Recognition Incentive (SRI) to provincial officials and employees for their invaluable contribution, commitment and dedication to public service;

**WHEREAS**, the Supplemental Investment Program also includes the implementation of other priority programs and projects of the Province and the acquisition of lands as part of the land banking initiative intended for future development projects;

**WHEREAS**, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;
