PROVINCIAL RESOLUTION NO. 1057-2023

FAVORABLY ENDORSING AND INTERPOSING NO OBJECTION TO THE PROPOSED REDEVELOPMENT OF THE PROVINCIAL CAPITOL COMPLEX, LINGAYEN, PANGASINAN

WHEREAS, the Provincial Capitol Complex is a significant landmark in the province, serving as a hub for various governmental activities and public services. However, due to changing times and evolving needs, it is essential to adapt and modernize the infrastructure to better serve the public;

WHEREAS, the proposed redevelopment plan envisions a comprehensive transformation of the Provincial Capitol Complex, aiming to enhance functionality, aesthetics, and accessibility. It includes the revitalization of existing buildings, construction of new facilities, implementation of green spaces, and improvements to infrastructure, public amenities and the war memorial;

WHEREAS, the benefits of this redevelopment project extend beyond mere physical renovations. By modernizing the Provincial Capitol Complex, it can create more efficient and citizen-centric environment. The new edifices will be better equipped to accommodate the increasing demands of government services, fostering effective decision-making processes and improved service delivery for the constituents;

WHEREAS, to bring this vision into fruition, and in order to gather support from various sectors of the society, a Public Consultation was conducted by the Provincial Government of Pangasinan on November 21, 2023 and held at the Pangasinan Training & Development Center 1. This activity was attended by officials and residents of Barangay Poblacion and Libsong West, Lingayen, Pangasinan and other stakeholders;

WHEREAS, in implementation of the project, trees and other vegetations will be cut/removed, and other existing structures will be affected by the Capitol Redevelopment Plan;

WHEREAS, coordination with the National Historical Commission of the Philippines (NHCP) has been made by the Provincial Government of Pangasinan relative to the relocation of historical landmarks and relics at the War Memorial. The new location historical landmarks and relics had been integrated in the redevelopment plan;

WHEREAS, there is a need for the Sangguniang Panlalawigan of Pangasinan to pass a resolution favorably endorsing and interposing no objection to the proposed Redevelopment of Provincial Capitol Complex, as well as the cutting/removal of trees and vegetations and the relocation of historical landmarks and relics;
