**ADOPTING THE ENHANCED LOCAL CLIMATE CHANGE
ACTION PLAN FOR 2024-2030 OF THE PROVINCE OF
PANGASINAN**

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Updating of the Enhanced Local Climate Change Action Plan for the Province of Pangasinan as adopted by the Provincial Disaster Risk Reduction and Management Council through PDRPMC Resolution No. 5, S-2023;

WHEREAS, the Enhanced Local Climate Change Action Plan contains policies and measures that the Province shall implement and streamline to be able to adopt to climate change and to mitigate its effects;


