PROVINCIAL RESOLUTION NO. 1060-2023

URGING THE SANGGUNIANG KABATAAN IN THE PROVINCE OF PANGASINAN TO INCLUDE PRIORITY PROGRAMS/PROJECTS AND BUDGET ALLOCATION FOR CLIMATE CHANGE ADAPTATION AND MITIGATION IN THEIR LOCAL YOUTH DEVELOPMENT PLANS

WHEREAS, the world today is facing challenges on climate change, environmental degradation and other disaster risks which require the cooperation and involvement of all stakeholders to address the same;

WHEREAS, climate change adaptation and mitigation programs and projects play important roles in raising awareness and educating people, especially the youth, about the consequences of climate change;

WHEREAS, the young people are considered development partners of the government and they should be at the forefront in the fight for climate and environmental protection;

WHEREAS, there is a need to tap the energy, enthusiasm and idealism of the Sangguniang Kabataan and involve their participation in the formulation and budgeting for climate change adaptation and mitigation programs and projects;

WHEREAS, Section 2 (d) of RA 10121 or the Philippine Disaster Risk Reduction Management Act of 2010 provides the adoption of a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socio-economic and environmental impacts of disasters including climate change, and promotes the involvement and participation of all sectors and all stakeholders concerned, at all levels, especially the local community;

WHEREAS, Section 11 (b) (2) thereof also states to “ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;”

WHEREAS, Joint Memorandum Circular No. 1, S-2019 of the Department of Budget and Management (DBM), Department of the Interior and Local Government (DILG), and National Youth Commission (NYC), dated January 23, 2019, provides that “in the preparation of the SK Annual Budget, priority should be given to youth development and empowerment programs, projects and activities in accordance with the Philippine Youth Development Plan and Local Youth Development Plan, as embodied in the approved CBYDP and ABYIP, that will promote environmental protection and climate change adaptation;”


WHEREAS, the Province of Pangasinan, through the Provincial Disaster Risk Reduction and Management Council (PDRPMC), led by the Provincial Governor Ramon V. Guico III, in full support for this endeavor, has approved Resolution No. 6, S-2023 on climate change adaptation and mitigation involving the Sangguniang Kabataan of the Province of Pangasinan for youth development and empowerment programs;

WHEREFORE, in view of the foregoing, on motion of SP Member Joyce D. Fernandez, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to urge, as they are hereby urged, the Sangguniang Kabataan in the Province of Pangasinan to include priority programs/projects and budget allocation for climate change adaptation and mitigation in their Local Youth Development Plans;
