PROVINCIAL RESOLUTION NO. 1062-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN MEMORANDA OF AGREEMENT (MOA) BETWEEN AND AMONG THE SCHOOLS DIVISION OFFICES IN THE PROVINCE OF PANGASINAN FOR THE ESTABLISHMENT OF A COLLABORATIVE FRAMEWORK TO ENSURE CLEAR DELINEATION OF ROLES AND RESPONSIBILITIES IN USING PUBLIC SCHOOLS AS EVACUATION CENTERS DURING EMERGENCIES

WHEREAS, RA 10121 or the Philippine Disaster Risk Reduction Management Act of 2010 paved the way for the adoption of a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socio-economic and environmental impacts of disasters including climate change and which promote involvement and participation;

WHEREAS, the Province of Pangasinan has been determined in defining its role in continually and responsibly implementing policies, programs and projects aimed towards the development and improvement of disaster risk reduction and management in the Province;

WHEREAS, there is a need for the Province of Pangasinan to establish a collaborative framework with the Schools Division Offices to ensure clear delineation of roles and responsibilities in using public schools as evacuation centers during emergencies in order to foster efficient and coordinated responses;

WHEREAS, the establishment of a collaborative framework between the Province of Pangasinan and Pangasinan DepEd is in pursuance to RA 10121;

WHEREAS, the Memoranda of Agreement (MOA) will serve as a vehicle for collaborative efforts between the Province of Pangasinan and the DepEd Pangasinan for the use of public schools as potential evacuation centers during emergencies;

WHEREAS, the MOA is necessary for the Province of Pangasinan and the DepEd Pangasinan to identify the specific terms required in the agreement;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, the MOA shall be entered into and sign between the Province of Pangasinan, represented by the Provincial Governor, Ramon V. Guico III, and the Schools Division Office Pangasinan I, Lingayen, Pangasinan, represented by its Schools Division Superintendent, Dr. Fatima R. Boado; Schools Division Office Pangasinan II, Binalonan, Pangasinan, represented by its Schools Division Superintendent, Dr. Lorna G. Bugayong; Schools Division Office Alaminos City, Pangasinan, represented by its OIC-Schools Division Superintendent, Dr. Vivian Luz S. Pangatpatan; Schools Division Office San Carlos City, Pangasinan, represented by its OIC-Schools Division Superintendent, Dr. Sheila Marie A. Primicias; Schools Division Office Urdaneta City, Pangasinan, represented by its Schools Division Superintendent, Dr. Aguedo C. Fernandez; and Schools Division Office Dagupan City, Pangasinan, represented by its Schools Division Superintendent, Dr. Rowena C. Banzon;

WHEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign Memoranda of Agreement (MOA) between and among the Schools Division Offices in the Province of Pangasinan for the establishment of a collaborative framework to ensure clear delineation of roles and responsibilities in using public schools as evacuation centers during emergencies;

RESOLVED, FURTHER that copies of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan, and to all concerned authorities, for their information and guidance.
