RESOLUTION NO. 1066-2023

DECLARING MUNICIPAL ORDINANCE NO. 12, S-2023 OF THE SANGGUNANG BAYAN OF MABINI, PANGASINAN, ENTITLED “AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO ALL FARMERS IN THE MUNICIPALITY OF MABINI, AND APPROPRIATING THE NECESSARY FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Municipal Ordinance No. 12, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in line with the Section 16 of R. A. No. 7160 and Republic Act No. 11321, otherwise known as the “Sagip Saka Act”;

WHEREAS, the appropriation for financial assistance to farmers which will come from the Special Purpose Appropriation under the General Fund of the LGU for CY 2024 shall be subject to existing accounting and auditing rules and regulations;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—


