RESOLUTION NO. 1068-2023

APPROVING RESOLUTION NO. 2023-244 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3, CY 2023 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2023-244 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 3 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 6, Series of 2023 dated September 26, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP, which has an investment requirement of P20,000,000.00, covers fund augmentation for Maintenance and Other Operating Expenses (MOOE) of some offices of the LGU; and
3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 3 for CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-03 dated October 20, 2023.


