#### **RESOLUTION NO. 1069-2023**

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2023 OF MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P20,000,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2023 involving total appropriations of Php20,000,000.00 which was enacted on October 20, 2023 through Appropriation Ordinance No. 2023-03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance to Section 321 of R.A 7160 and Article 414 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- That all procurement to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations; and

3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2023 Annual Investment Program of the municipality and supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—
