APPROVING RESOLUTION NO. 2023-303 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 5, FOR THE CALENDAR YEAR 2023 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2023-303 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 05. This was endorsed to the Sangguniang Bayan for approval on September 11, 2023 by the Municipal Development Council thru Resolution No. 2023-07;
2. Said SAIP No. 5 of the municipality with an investment requirement of Php5,000,000.00 covers the implementation of programs/projects to be funded from the Local Government Support Fund-Financial Assistance to LGUs (LGSF-FA); and

3. The identified project proposed to be funded from the LGSF-FA to LGUs are in accordance with Local Budget Circular No. 150 dated March 8, 2023 “Guidelines on the Release and Utilization of the Local Government Support Fund-Financial Assistance to Local Government Units and Support for Capital Outlays and Social Programs Under the FY 2023 General Appropriations Act, Republic Act No. 11936”.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was –


