APPROVING RESOLUTION NO. 2023-318 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 6 FOR THE CALENDAR YEAR 2023 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2023-318 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 6 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on October 10, 2023 by the Municipal Development Council thru Resolution No. 2023-08;
- 2. The said SIP No. 6 of the municipality cover fund augmentation for Personal Services (granting of Performance Based Bonus to qualified official and employees of the LGU) and Maintenance and Other Operating Expenses of various offices and implementation of programs and projects of the municipality; and

3. Funding support for the implementation of the same in the amount of Php10,910,258.54 is embodied in their proposed Supplemental Budget No. 03 for Calendar Year 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2023-04 on October 16, 2023 and approved by the Municipal Mayor on November 6, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—
