APPROVING RESOLUTION NO. 40, S-2023 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2, CY-2023 OF THE SUPPLEMENTAL BUDGET NO. 2, S-2023 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its SB Resolution No. 40, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Local Development Council of San Quintin, Pangasinan has formulated and adopted the municipality's Supplemental Investment Program No. 2 thru MDC Resolution No. 2, S. 2023 dated September 15, 2023 and endorsed the same to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program No. 02 with an investment requirement amounting to Php7,581,267.63, covers fund augmentation for Personal Services (granting of Productivity Based Bonus to qualified officials and employees' of LGU San Quintin) and the implementation of development programs and projects in the municipality; and

3. The Sangguniang Bayan enacted Supplemental Budget No. 2, for Calendar Year 2023 through Appropriation Ordinance No. 5, S-2023, dated October 23, 2023 to support the full implementation of the Supplemental Investment Program No. 02 of LGU San Quintin.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Quintin, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—
