RESOLUTION NO. 1077-2023

DECLARING MUNICIPAL ORDINANCE NO. 146, S-2023 OF THE SANGGUNANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING THE IMPROPER WASTE DISPOSAL OF PLASTIC BOTTLES, GLASS, PLASTIC BAGS, CONTAINERS OR CANISTER FOR PESTICIDE AND OTHER CHEMICAL SUBSTANCES USED IN AGRICULTURAL PRODUCTION WITHIN THE ANCESTRAL DOMAINS IN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN PROVIDING PENALTIES IN VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 146, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance to Sections 17 (a) (2) (vi) & 447 (1) (vi) (3) (ii) (5) & (i) of R. A. No. 7160; Article II of the 1987 Philippine Constitution; Republic Act No. 8749, or the Philippine Clean Air Act of 1999; and Republic Act No. 9003, otherwise known as the “Ecological Solid Waste Management Act of 2000”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—
