RESOLUTION NO. 1079-2023

DECLARING MUNICIPAL ORDINANCE NO. 153, S-2023 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "THE NEW COMPREHENSIVE ANTI-SMOKING ORDINANCE OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 153, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with the Sections 16 and 447 (a) (3) & (ii) of R. A. No. 7160; Executive Order No. 26, entitled: "Providing for Establishments of Smoke-Free Environments in Public and Enclosed Places"; Section 24 of the Republic Act No. 8749, otherwise known as the "Philippine Clean Air Act of 1999"; and Section 5 (a) (b) (c) (d) & (e) of the Republic Act No. 9211, or "Tobacco Regulation Act of 2003;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Arthur C. Celeste, Jr. and Joyce D. Fernandez, duly seconded, it was—


