APPROVING RESOLUTION NO. 2022-360 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 8, CY 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2022-360 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council – Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 8 for CY 2022. This was endorsed by the Council, through MDC – ExeCom Resolution No. 8, Series of 2022 dated December 27, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental AIP, which has an investment requirement of P1,774,000.00, covers fund augmentation for Personal Services (granting of the Gratuity Pay for Job Orders, Contract of Service and Hired Service Employees of the LGU); and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 7 for CY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-09 dated December 28, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;
