#### **PROVINCIAL RESOLUTION NO. 1089-2023**

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A TRIPARTITE MEMORANDUM OF UNDERSTANDING (MOU) WITH THE COLLEGES AND INSTITUTE CANADA AND THE PANGASINAN POLYTECHNIC COLLEGE FOR THE ESTABLISHMENT OF A PARTNERSHIP FOR MUTUAL COOPERATION ON INTERNATIONAL EDUCATION AND LOCAL PRACTICAL APPLICATIONS

**WHEREAS**, the Colleges and Institutes Canada is a non-profit organization, and Canada's largest association of publicly funded colleges, polytechnics, cegeps, and institutes;

**WHEREAS**, the Pangasinan Polytechnic College is a public, non-sectarian, non-partisan technical-vocational, and higher educational institution operating primarily from the subsidy of the Provincial Government of Pangasinan;

WHEREAS, the Colleges and Institutes Canada, the Pangasinan Polytechnic College and the Provincial Government of Pangasinan aim to facilitate the exploration of partnership and collaboration opportunities to bring high-quality applied learning programs in the Province of Pangasinan;

WHEREAS, the Pangasinan Polytechnic College seeks support for the establishment of micro-credentials and a localized leadership program, and capacity building for curricula development, teacher training, and indigenous community inclusion policies and procedures;

WHEREAS, the collaboration will contribute to the understanding between and among the parties to open new possibilities in applied research, technical and vocational education and training, industry linkages and inclusivity;

**WHEREAS**, the Colleges and Institutes Canada, the Pangasinan Polytechnic College and the Provincial Government of Pangasinan intend to establish potential areas of collaboration in the fields of education, tourism, trade and agriculture;

WHEREAS, it is to the best interest of the Province of Pangasinan to sign the Memorandum of Understanding (MOU) with the Colleges and Institutes Canada and the Pangasinan Polytechnic College for the establishment of a partnership for mutual cooperation on international education and local practical applications;

**WHEREAS,** the duties and responsibilities of every party for the partnership are already defined in the Tripartite MOU;

**WHEREAS,** Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, the Tripartite Memorandum of Understanding shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, the Pangasinan Polytechnic College, represented by its Interim President, Dr. Raymundo D. Rovillos and the Colleges and Institutes Canada, represented by its Vice President, Mr. Alain Roy;

**NOW, THEREFORE,** on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was –

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Tripartite Memorandum of Understanding (MOU) with the Colleges and Institute Canada and the Pangasinan Polytechnic College for the establishment of a partnership for mutual cooperation on international education and local practical applications;

**RESOLVED, FINALLY,** that copies of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan, Dr. Raymundo D.
