APPROVING RESOLUTION NO. 70, S-2022 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 4 FOR CY-2022 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P2,973,622.73 FROM THE GENERAL FUND AND P3.666,264.61 FROM THE ECONOMIC ENTERPRISE"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 70-S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 4 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 07-S. 2022 dated December 5, 2022, to the Sangguniang Bayan for approval;
- 2. Said Supplemental AIP, which has an investment requirement of \$\pmu_6,639,887.34\$, covers the augmentation of funds for Maintenance and Other Operating Expenses (MOOE) of the Municipal Government, and implementation of LDRRM programs and other priority projects of the LGU; and

3. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 5 for CY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 6, S-2022 dated December 27, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Fabian, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 70-S-2022 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled "Approving the Supplemental Annual Investment Plan No. 4 for CY-2022 of the Local Government of San Fabian, Pangasinan in the Amount of P2,973,622.73 from the General Fund and P3,666,264.61 from the Economic Enterprise";
