APPROVING RESOLUTION NO. 2022-103 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 05 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00)"

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2022-103 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Laoac, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No.05 Series of 2022. This was endorsed to the Sangguniang Bayan for approval on December 27, 2022 by the Municipal Development Council-Executive Committee thru Resolution No. 2022-02;
- 2. Said SAIP covers fund augmentation for Personal Services on the granting of gratuity pay to qualified contract of service (COS) and job order (JO) workers of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP150,000.00 is embodied in their proposed Supplemental Budget No. 4 for Calendar Year 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No.2022-005 on December 28, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
