- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and
- 2. That the grant of Gratuity Pay to Contract of Service and Job Order Workers in the municipality shall be in accordance with the provisions of Budget Circular No. 2022-5 of the Department of Budget and Management dated December 28, 2022.
