### RESOLUTION NO. 117-2023

**APPROVING RESOLUTION NO. 2022-277 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 2<sup>ND</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2022 OF THE MUNICIPALITY OF SISON, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2022-277, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sison, Pangasinan had identified items in their 2<sup>nd</sup> Supplemental Annual Investment Program (SAIP) for CY 2022, which was endorsed to the Sangguniang Bayan for approval on December 22, 2022 through MDC Resolution No. 03-2022 Series of 2022;
2. The 2<sup>nd</sup> SAIP of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive to permanent employees, Gratuity Pay to Contract of Service and Job Order workers, and other personnel benefits) and the implementation of priority programs/projects of the LGU with a total investment requirement of Php5,190,432.00;

3. Funding for this SAIP is supported by Supplemental Budget No.02 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 03, Series of 2022 on December 27, 2022; and
4. The proposed programs/projects to be funded from the share of the LGU from Tobacco Excise Tax CY2022 are consistent with Local Budget Memorandum No. 86 dated December 14, 2022 (Guidelines on the Release and Utilization of the Shares of LGUs from the FY 2020 Collections of Excise Taxes on Locally Manufactured Virginia-Type Cigarettes under RA No. 7171 and Burley and Native Tobacco Excise Taxes pursuant to 8240, as amended by RA No. 10351, and as further amended by RA No. 11346, chargeable against the Allocations to LGUs under FY 2022 General Appropriations Act, RA No. 11639).

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sison, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
