**RESOLUTION NO. 118-2023**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 02 FOR  
CALENDAR YEAR 2022 OF SISON, PANGASINAN INVOLVING  
A TOTAL APPROPRIATION OF P5,190,432.00, OPERATIVE IN  
ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Supplemental Budget No. 02 for Calendar Year 2022 involving total appropriations of P5,190,432.00, which was enacted on December 28, 2022 through Appropriation Ordinance No. 03, Series of 2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the utilization of appropriations from FY 2020 shares of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum No. 86 dated December 14, 2022;
2. That the grant of Other Personnel Benefits - Service Recognition Incentive (SRI) to regular and casual employees for Fiscal Year 2022 shall be subject to the provisions of Administrative Order No. 1 dated December 16, 2022 by the Office of the President;

3. That the grant of gratuity pay to contract of service and job order workers shall be in accordance with Budget Circular No. 2022-5 dated December 28, 2022;
4. That the grant of Rice Assistance for FY 2022 to all municipal officials, regular and casual employees of municipality shall be in accordance with the provisions of Administrative Order No. 02 dated December 16, 2022;
5. That all programs, projects and activities shall be in accordance with the approved CY 2022 Supplemental Investment Program of the Municipality; and
6. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations.


**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


