RESOLUTION NO. 120-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 6 FOR CALENDAR YEAR 2022 OF ASINGAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,303,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Supplemental Budget No. 6 for Calendar Year 2022 involving total appropriations of P1,303,000.00, which was enacted on December 29, 2022 through Appropriation Ordinance No. 6, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the grant of Gratuity Pay to contract of service and job order workers shall be in accordance with Budget Circular No. 2022-5 dated December 28, 2022; and

3. That the grant of Rice Assistance for FY 2022 to all municipal officials, regular and casual employees of municipality shall be in accordance with the provisions of Administrative Order No. 02 dated December 16, 2022.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;
