APPROVING RESOLUTION NO. 2022-113 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 4 FOR THE CALENDAR YEAR 2022 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2022-113 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan had identified items in their Supplemental Investment Program (SIP) No.3 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on December 1, 2022 by the Municipal Development Council thru Resolution No. 2022-07;
- 2. The SAIP No.4 of the municipality covers fund augmentation for Maintenance and Other Operating Expenses of some municipal offices, Capital Outlay and the implementation of disaster risk reduction programs of LGU Balungao; and

3. Funding support for the implementation of the same in the amount of PhP1,086,538.35 is embodied in their proposed Supplemental Budget No. 4 for Calendar Year 2022 which was enacted by their Sangguniang thru Appropriation Ordinance No. 2022-05 on December 12, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
