## **RESOLUTION NO. 123-2023**

183-2022 OF THE APPROVING RESOLUTION NO. BAYAN OF ROSALES, PANGASINAN, SANGGUNIANG ENTITLED "APPROVING SUPPLEMENTAL BUDGET NO. 04 CY 2022 INVOLVING AN AMOUNT OF THREE MILLION AND FORTY THOUSAND PESOS (P3,040,000.00) FUNDED FROM SAVINGS FROM PERSONNEL SERVICES FOR PURPOSES OF IMPLEMENTATION OF SERVICE INCENTIVE OF MUNICIPAL OFFICIALS AND EMPLOYEES IN VARIOUS OFFICES IN THE MUNICIPALITY OF ROSALES, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 183-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

 Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council (Executive Committee) of Rosales, Pangasinan has identified items in their Supplemental Investment Program 2 for CY 2022. This was endorsed to the Sangguniang Bayan on December 22, 2022 through MDC Resolution No. 1222 S. 2022;

- 2. The SIP No. 4 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive (SRI) to the municipal government officials and employees of LGU Rosales); and
- 3. Funding support for the proposed SIP, with a total investment requirement of PhP3,040,000.00 is embodied in the municipality's Supplemental Budget No.04, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05-2022 on December 22, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Rosales, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 183-2022 of the Sangguniang Bayan of Rosales, Pangasinan, entitled "Approving Supplemental Budget No. 04 CY 2022 Involving an Amount of Three Million and Forty Thousand Pesos (P3,040,000.00) Funded from Savings from Personnel Services for Purposes of the Implementation of Service Recognition Incentive of Municipal Officials and Employees in Various Offices in the Municipality of Rosales, Pangasinan";
