RESOLUTION NO. 125-2025

APPROVING RESOLUTION NO. 198, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE FIFTH SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 198, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their Fifth Supplemental Annual Investment Program (SAIP) for CY 2024. This was endorsed to the Sangguniang Bayan on December 12, 2024 through MDC Resolution No. 11, Series of 2024 and was favorably acted upon by the Sangguniang Bayan on December 16, 2024 through Resolution No. 198, Series of 2024;
2. The SAIP No. 05 covers fund augmentation for the Personal Services (Granting of Service Recognition Incentive and Collective Negotiation Agreement to all Qualified Municipal Officials and Employees, and Other Personnel Benefits), Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and implementation of development projects and disaster risk reduction programs of the LGU; and

3. Funding support for the implementation of said SAIP is embodied in the municipality's Supplemental Budget No. 5 CY 2024 amounting to PhP17,973,562.52, which was approved and enacted by their Sangguniang Bayan on December 16, 2024 through Appropriation Ordinance No. 06, Series of 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
