APPROVING RESOLUTION NO. 2024-210 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4 FOR CY 2024 OF SUAL, PANGASINAN AMOUNTING TO ELEVEN MILLION TWO HUNDRED FORTY-THREE THOUSAND FIVE HUNDRED FIFTY-SIX & 99/100 PESOS (P11,243,556.99)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2024-210 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 4 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on October 2, 2024 by the Municipal Development Council thru Resolution No. 7, Series of 2024, and was favorably acted upon by the Sangguniang Bayan on October 22, 2024 thru Resolution No. 2024-210;
2. The SIP No. 3 of the municipality covers fund augmentation for the Maintenance and Other Operating Expenses of some municipal government offices and the implementation of disaster risk reduction and management programs/projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP11,243,556.99 is embodied in their proposed Supplemental Budget No. 04 CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No.05, CY 2024 on October 22, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
