APPROVING RESOLUTION NO. 2022-122, SERIES OF 2022 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2022-03 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN, FOR CALENDAR YEAR 2022, REQUIRING A TOTAL FUNDING OF FIVE MILLION, SIX HUNDRED FORTY TWO THOUSAND FIVE HUNDRED SEVENTY FIVE PESOS (P5,642,575.00)”

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2022-122, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 03, CY 2022. This was endorsed by the Council, through MDC Resolution No. 2022-14, Series of 2022 dated December 1, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental AIP, which has a total investment requirement of ₱5,642,575.00, covers augmentation of funds for Personal Services (granting of Collective Negotiation Agreement Incentives to qualified municipal officials and employees) and Capital Outlay of the LGU; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2022-03, FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-010, Series of 2022 dated December 9, 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;


