DECLARING ORDINANCE NO. 230, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTILED "AN ORDINANCE STRENGTHENING THE IMPLEMENTATION AND MONITORING OF R.A. 8172, OTHERWISE KNOWN AS THE "ACT PROMOTING SALT IODIZATION NATIONWIDE (ASIN) AND FOR RELATED PURPOSES" IN THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 230, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of R.A. No. 7160, Section 2 of R.A. No. 8172 or the "Act Promoting Salt Iodization Nationwide and for Related Purposes", and Section 2 of R.A. No. 10611 or the "Food Safety Act of 2013";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
