RESOLUTION NO. 135-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 6 FOR CALENDAR YEAR 2022 OF MAPANDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF PHP485,057.48, OPERATIVE IN ITS ENTIRETY.

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Supplemental Budget No. 6 for Calendar Year 2022 involving total appropriations of Php485,057.48, which was enacted on December 19, 2022 through Appropriation Ordinance No. 6, S-2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and

2. That the appropriation for Other Maintenance and Operating Expenses shall cover only other expenses not otherwise classified under any of the specific maintenance and other operating expense accounts, in accordance with the Revised Chart of Accounts for LGUs under COA Circular No. 2015-009 dated December 1, 2015


