**APPROVING RESOLUTION NO. 072-2024 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF LABRADOR, PANGASINAN FOR CY 2025 IN THE TOTAL AMOUNT OF ONE HUNDRED SEVENTY FOUR MILLION ONE HUNDRED FORTY FIVE THOUSAND THREE HUNDRED NINETEEN PESOS (P174,145,319.00)”**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 072-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject Resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code of 1991. The Municipal Development Council of Labrador, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2025. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 004-S-2024 dated September 5, 2024, and was favorably acted upon by the Sangguniang Bayan through SB Resolution No. 072-2024 dated October 21, 2024;

2. The Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2023 Edition, and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007, DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015. The AIP of Labrador is categorized into general public, social, economic and other services sectors, and covers (a) all the regular budgetary requirements for the operation of the different offices broken down into Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, (b) priority development programs/projects of the LGU, including those funded by the 20% Development Fund, (c) Disaster-Risk Reduction (DRR) programs, projects, and activities, and (d) activities in pursuance of the objectives of Gender and Development (GAD) of the LGU as indicated in the DILG-endorsed GAD Plan and Budget;

Also attached to the AIP are the following: (a) Local Climate Change Action Plan, (b) Peace and Order Plan, (c) Local Nutrition Action Plan, (d) Municipal Tourism Culture Heritage Promotion and Conservation Plan, (e) Local Youth Development Plan, (f) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children and Children with Disability, (g) List of PPAs for Senior Citizens, Persons with Disability of the LGU, (h) List of PPAs to Combat AIDS, Local Anti-Drug Abuse Plan of Action and (i) Annual Project Procurement and Management Plan;

It is recommended, however, that the new prescribed AIP Summary Form be used by the LGU in their succeeding AIPs and Supplemental AIPs as per Local Budget Memorandum No. 90 dated June 13, 2024;

3. The proposed AIP of Labrador for CY 2025 has a total investment requirement of P174,145,319.00 which will be financed by the LGU as embodied in their proposed Annual Budget for CY 2025 and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02-2024 dated October 21, 2024 and approved by the Municipal Mayor on October 30, 2024;
4. This AIP is in accordance with Section 287 of LGC of 1991. More than Twenty percent (20.11%) of the LGU's IRA/NTA (P159,113,319.00), amounting to P32,000,000.00, is allocated for development projects;

The development projects proposed to be funded by the 20% Development Fund were based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);

5. The programs, projects and activities (PPAs) proposed to be funded from the 5% Local Disaster Risk Reduction and Management Investment Fund, amounting to P8,707,270.00, is in accordance with RA 10121. The programs/projects/activities proposed to be funded from the 70% of the 5% LDRRMF (P6,095,089.00) are based on the Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund), and the 30% amounting to P2,612,181.00 is allocated for Quick Response Fund (QRF);

The LDRRM Plan of the LGU was forwarded to the Office of Civil Defense – Regional Office I for their review/evaluation as per attached references;

6. The LGU of Labrador had also identified programs, projects and activities which are responsive to Climate Change and tagged its corresponding expenditures in their AIP in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
7. The Gender and Development Plan and Budget for CY 2025 of the LGU was reviewed and approved by the DILG Provincial Office, and found to be compliant in form and content with the provisions of the PCW-DILG-DBM-NEDA Joint Memorandum Circular (JMC) Nos. 2013-01 and 2016-01 (Guidelines on the Localization of the Magna Carta of Women).

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Labrador, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 072-2024 of the Sangguniang Bayan of Labrador, Pangasinan, entitled “Approving the Annual Investment Program of the Municipality of Labrador, Pangasinan for CY 2025 in the total amount of One Hundred Seventy Four Million One Hundred Forty Five Thousand Three Hundred Nineteen Pesos (P174,145,319.00)”;


