PROVINCIAL RESOLUTION NO. 138-2023

**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 1 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2023**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 1 of the Province of Pangasinan for Calendar Year 2023 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 01-23;

WHEREAS, Supplemental Investment Program No. 1 contains other priority programs, projects and activities that are not included in the approved 2023 Annual Investment Program of the Province of Pangasinan;

WHEREAS, the Supplemental Investment Program covers the construction of Road Network and other Facilities for the Historical Site and Pilgrimage Area at Sitio Lubas, Barangay Sta. Catalina, Binalonan, Road Widening at Barangay Sta. Catalina, Binalonan, Pangasinan, counterpart fund for the Local Government Support Fund-Financial Assistance (LGSF-FA) funded projects and other priority development projects of the Province;

WHEREAS, funding for the said Supplemental Investment Program with the total amount of P689,000,000.00 will be sourced from the continuing appropriation CY 2022 20% Development Fund, namely: Community Development Projects; Construction/Repair and Maintenance of Provincial Roads and Bridges; Construction/Repair and Other Development Projects; Local School Board – Special Education Fund CY 2023; and current appropriations – 20% Development Fund;

WHEREAS, it is imperative to realign the Amortization of Loans (P107 M) and the Water and Sanitation (P7 M) to Community Development Project and Construction/Repair and other Development Project, all from the 20% Development Fund 2022, to augment the funds for the abovementioned projects;

NOW, THEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


