PROVINCIAL RESOLUTION NO. 139-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH ALV EVENTS INTERNATIONAL, INC. FOR ITS PARTICIPATION IN THE CONDUCT OF A BEAUTY PAGEANT SEARCH IN THE PROVINCE OF PANGASINAN

WHEREAS, one of the visions of the present administration is to make Pangasinan a premier province and its people worthy of international recognitions;

WHEREAS, it is the aim of the Provincial Government of Pangasinan to fulfill such vision by way of supporting and promoting its tourism development programs and projects;
