PROVINCIAL RESOLUTION NO. 140-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH CAROUSEL PRODUCTIONS, INC. FOR THE AWARDED OF THE FRANCHISE OF MISS PHILIPPINES EARTH 2023 TO THE PROVINCE OF PANGASINAN

WHEREAS, Carousel Productions, Inc. is the owner, organizer and producer of the Miss Philippines Earth Beauty Pageant, a national beauty pageant with active involvement in the preservation of the environment;

WHEREAS, with the objective to control and maintain the quality of candidates joining Miss Philippines Earth, Carousel Productions, Inc. will award local franchise to organization/corporation/partnership/individual that has the capability and experience to organize and produce beauty competition in the different provinces, cities and municipalities with the winner to be sent as representative to Miss Philippines Earth beauty pageant;

WHEREAS, Pangasinan which possesses the capability and experience to select its candidate to the Miss Philippines Earth beauty pageant has submitted its application to Carousel Productions, Inc., which the latter has accepted;

WHEREAS, a franchise agreement between the Provincial Government of Pangasinan and Carousel Productions, Inc. is necessary in order for the Province to officially host the selection of the latter's candidate to the Miss Philippines Earth beauty pageant;

WHEREAS, the Memorandum of Agreement is essential to identify the specific terms and conditions required in the grant of the franchise of Miss Philippines Earth 2023 to the Province of Pangasinan;



NOW THEREFORE, on motion of SP Member Marinor B. de Guzman, duly seconded, it was -


