RESOLUTION NO. 142-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 6 FOR CALENDAR YEAR 2022 OF AGNO, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF P1,710,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Supplemental Budget No. 6 for Calendar Year 2022 involving total appropriations of P1,710,000.00, which was enacted on December 19, 2022 through Appropriation Ordinance No. 2022-07;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the funding sources for the said supplemental budget were determined in accordance with Section 321 of RA 7160 and Article 417
 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;

- That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Supplemental Investment Program of the Municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
- That the grant of Gratuity Pay to Contract of Service and Job Order workers in the municipal government shall be in accordance with the provisions of Budget Circular No. 2022-5 dated December 28, 2022; and
- 5. That the grant of Service Recognition Incentive (SRI) to municipal employees for FY 2022 shall be subject to the provisions of Budget Circular No. 2022-4 dated December 20, 2022.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 6 for Calendar Year 2022 of Agno, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Agno, Pangasinan, for its information and guidance.
