**RESOLUTION NO. 143-2023**

**APPROVING RESOLUTION NO. 92-2022 OF THE SANGGUNANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 03, SERIES OF 2022 OF THE MUNICIPALITY OF ANDA, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its SB Resolution No. 92-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Anda, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 03 Series of 2022. This was endorsed to the Sangguniang Bayan for approval on December 23, 2022 by the Municipal Development Council through MDC Resolution No. 04 Series of 2022;
2. Said SIP covers fund augmentation for Personal Services (granting of Service Recognition Incentive and Collective Negotiation Agreement Incentive to all qualified LGU employees and officials, and other personnel benefits) and implementation of priority programs and projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP4,316,318.69 is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 04 Series of 2022 on December 27, 2022 and approved by the Municipal Mayor on December 28, 2022.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Anda, Pangasinan;


