RESOLUTION NO. 144-2023

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR
CALENDAR YEAR 2022 OF ANDA, PANGASINAN INVOLVING
A TOTAL APPROPRIATIONS OF P4,316,318.69, OPERATIVE IN
ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Anda Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2022 involving total appropriations of P4,316,318.69, which was enacted on December 27, 2022 through Appropriation Ordinance No. 04, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding source for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the grant of Service Recognition Incentive (SRI) to regular & casual employees for FY 2022 shall be subject to the provisions of Administrative Order No. 1 dated December 16, 2022 by the Office of the President;
3. That the appropriation for Collective Negotiation Agreement (CNA) Incentive for FY 2022 to all municipal officials & employees shall be subject to the provisions of Budget Circular No. 2022-3 of the Department of Budget & Management dated October 19, 2022, particularly Item 4.3.6, thereof; and
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2007 dated March 8, 2007.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


