### RESOLUTION NO. 145-2023

**APPROVING RESOLUTION NO. 153-2022 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 5 CALENDAR YEAR 2022 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Burgos, Pangasinan submitted its SB Resolution No. 153-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Burgos, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No.5 CY 2022. This was endorsed to the Sangguniang Bayan for approval on December 21, 2022 by the Municipal Development Council-Executive Committee through Resolution No. 001 Series of 2022;
2. Said SAIP covers fund augmentation for Personal Services for the granting of Service Recognition Incentive to LGU employees and officials; and

3. Funding support for the implementation of the same in the amount of PhP 3,487,400.00 is embodied in their proposed Supplemental Budget No. 05 for FY 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 06-2022 on December 22, 2022.


